GLOSARIUM

- Asertivitas* : Suatu bentuk diplomasi yang secara eksplisit mengancam aktor-aktor politik internasional lainnya dan jelas-jelas lebih tinggi daripada sebelumnya.
- Balancing* : Strategi perimbangan kekuasaan dengan cara melawan negara dominan secara langsung.
- Bandwagoning* : Strategi di mana suatu negara atau beberapa negara bersekutu dengan negara dominan.
- Engagement* : Diplomasi secara lebih spesifik dan erat dengan aktor politik internasional lainnya.
- Internal Balancing* : Strategi peningkatan kekuatan suatu negara dalam hal sumberdaya ekonomi dan militer agar dapat mengandalkan kemampuan internal dalam merespon negara dominan.
- Non-Balancing* : Apabila suatu negara merasakan peningkatan ancaman dari negara dominan, tidak ada perubahan kebijakan yang menyesuaikan peningkatan tersebut, sehingga sebuah negara masing menggunakan *status quo policy*. Non-balancing terjadi karena ada fragmentasi di dalam elite politik perumus kebijakan.
- Standoff* : Ketegangan antara dua kapal dengan otoritas yang berbeda namun tidak ada kontak fisik antar mereka.
- Under-Balancing* : Respon suatu negara yang lalai dan tidak berhati-hati atas peningkatan ancaman dari negara dominan.
